Airfield Fueling Station | Ft Knox, KY | \$4.2M | US Army Corps of Engineers (USACE) | *Design-Build of jet fueling system including: replacement of existing wood canopy structure/lighting, truck parking, lighting/grounding system; repair of fueling system; installation of new prover stations, temperature compensation meter, load/offload pump control panel, and grounding system; new thermal relief valves installed; non-compliant pump skids replaced; new truck offloading/loading fillstand*

Fueling System & Building Repairs | Camp Pendleton, CA | \$1.3M | USACE | *Repairs to buildings 23214 & 23185, repair of fuel equipment at pump shelter, replace guard shack, installation of a sanitary sewer lift station and force main, and repairs to pavement and lighting*

Upgrade Remote Aircraft Fueling Facility | Sitkinak, AK | \$1.1M | USACE/US Coast Guard (USCG) | *Mechanical fuel shelter included all fuel system equipment: integral containment, operating tanks, filtration, pumps, control valves, controls, and other components*
