DOE ADVANCED MANUFACTURING COLLABORATIVE FACILITY

University of South Carolina

LBYD Federal completed the full 100% design, supporting DOE missions by enabling research and development outside the restricted Savannah River Site. The facility brings together national laboratories, industry partners, and academic institutions to drive innovation and advanced technology development. Key spaces include laboratories, manufacturing areas, training spaces, offices, and a small-business incubator.



DOE PADUCAH INFRASTRUCTURE SUPPORT

Paducah, Kentucky

BLM MULTI-AGENCY MASTER PLAN

Pocatello, Idaho

Joint Base Elmendorf-Richardson, Alaska

AIR FORCE RESEARCH LAB CONSTRUCTION & ENGINEERING SUPPORT

Kirtland Air Force Base

LBYD Federal provides ongoing infrastructure management and facility support for the Air Force Research Laboratory at Kirtland AFB, supporting 45 facilities dedicated to directed energy and space vehicle research. Embedded, cleared staff deliver engineering, project management, and facility support, including design reviews, construction oversight, maintenance, and coordination—supporting over 40 projects from planning through completion.

SOLE SOURCE

- **No Competitive Threshold Limit** – ANC 8(a) firms are exempt from the \$4.5M competitive threshold [13 CFR 124.506(b)(1)].
- **Sole Source Limits** – Sole source awards up to \$22M do not require Justification & Approval (J&A) [13 CFR 124.506(b)]; awards above \$22M require J&A [NDAA FY2010 Sec. 811; 48 CFR 6.303].
- **DoD Exception** – As of March 17, 2020, DoD may issue sole source awards up to \$100M without J&A, superseding the \$22M threshold in FAR 6.302-5(b)(4), 6.303-1(b), 6.303-2(d), and 19.808-1(a).
- **No Protests** – Sole source 8(a) awards are not subject to size or eligibility protests [13 CFR 124.517].
- **Follow-on Work** – ANC 8(a) firms may receive follow-on contracts for previously performed 8(a) work [13 CFR 124.109(c)(3)(iii)].

HOW TO ORDER

1. **Establish Project Requirements**—develop a well-defined performance work statement with best value criteria.
2. **Review the OASIS+ Buyer’s Guide**—at gsa.gov.
3. **Coordinate with your Contracting Officer**—advise that you have identified LBYD Federal as a Best-In-Class 8(a)-service provider on OASIS+.
4. **Confirm Delegation of Procurement Authority**—your CO must have this to access OASIS+.
5. **Contact a GSA Account Manager**—request market research to confirm LBYD Federal as a preferred option.
6. **Consider Sole Source Procedures**—to accelerate procurement and project delivery; CO submits an “offering letter” to our SBA representative.
7. **Post in GSA eBuy**—in the 8(a) pool and Technical & Engineering domain.
8. **Execute**—evaluate proposals, award contract, and successfully execute your project with LBYD Federal.
